AGREEMENT

3. Not to use courts other than my booked times

4. NOT to pass the key to others for their unauthorized use of the Courts

5. To return the key the day after my final use of the courts for the Year

6. TO PAY THE FEES FOR THE COURT HIRE by the end of the first week of the next month.

7. We accept that inability to play for whatever reason still incurs a booking fee of 50% of court hire

8. Minimum special rates hiring: NIGHTS- to end NOV, SCHOOL AM – to end of term, OTHER RATE – six months.

Any variations from the above must be authorized by the Ferny Hills Progress Association Inc. I understand that failure of any of the above will lead to difficulties with hiring the courts again.
